

OVERVIEW

For decades, West African women have mobilized for legal recognition of gender equality, yet the intersection between women's mobilizations and the law remains understudied. The GLOW research project bridges this gap by exploring the relationship between gender, activism, and law in West Africa from the 20th to the 21st century. By examining the history of women's struggles for legal rights, the project offers fresh perspectives on the region's political and social history during both colonial and post-colonial periods. It also provides new insights into the legal construction of political and social inequalities over time.

GLOW adopts a multidisciplinary approach, bringing together historians, sociologists, anthropologists, political scientists, and legal experts to overcome disciplinary and methodological barriers. The project emphasizes multiscalar analysis, examining both local mobilizations and the impact of international standards on legislation. Collaboration between Anglophone and Francophone researchers is central to the project, highlighting differences and similarities in legal heritage while transcending linguistic and imperial boundaries.
